APPLICATION

1. Parties:

1.1. Applicant herein is Blake Production Company, Inc., whose address for the purposes hereof is 1601 Northwest Expressway, Suite 777, Oklahoma City, OK 73118. The landman for the Applicant is Charles Woner, Telephone: (405) 286-9800.

1.2. Applicant is the owner of the right to drill a well into and produce hydrocarbons from the Mississippi common source of supply underlying the 640-acre drilling and spacing unit comprised of Section 33, Township 23 North, Range 16 West of the IM, Major County, Oklahoma.

1.3. Exhibit "A" lists the name and last-known address of each person or entity being made a respondent in this cause.

2. Allegations of Fact:

2.1. By Order No. 138175, dated February 8, 1978, as corrected by Order No. 138851, dated March 8, 1978, the Commission formed a 640-acre drilling and spacing unit comprised of Section 33, Township 23 North, Range 16 West of the IM, Major County, Oklahoma, for the Mississippi common source of supply.

2.2. Applicant has conducted a diligent and meaningful search of the local county assessor's records, county treasurer's records, county deed records regarding the property involved for return addresses on recorded instruments, county probate records, city and county telephone directories and other sources of such information to locate each respondent and has made a bona fide effort to reach an agreement as to the development of said unit with each respondent located by such search.

2.3. Applicant has drilled or proposes to drill a well on said drilling and spacing unit to test the common source of supply set out above. The avoiding of drilling of unnecessary wells, the prevention of waste, and the protection of correlative rights require that the Commission order all owners to pool their interests and to drill and develop the drilling and spacing unit and common source of supply as a unit.

(ii) Designating the Applicant or some other party recommended by the Applicant as operator under the order to be entered in this cause of the common source of supply in the drilling and spacing unit involved herein, including the initial well and any subsequent wells under Applicant's proposed plan of development of such unit.
