1. <u>Parties</u>: Applicant, Continental Resources, Inc., P.O. Box 269091, Oklahoma City, OK 73126, is the owner of oil and gas leasehold interests within the lands described in the caption hereof. The Respondents to this Application are shown on the Exhibit "A" attached hereto.

- a. By Order No. 580767, this Commission established 640-acre drilling and spacing units for the Sycamore and Woodford common sources of supply underlying Section 29, Township 1 South, Range 2 West, Carter County, Oklahoma.
- b. The well pattern and density prescribed by said Order are not adequate when taking into consideration the changed conditions which now prevail as compared to conditions known when such well pattern and density were first ordered.
